Special Constituency Report

Delegates reaffirm strong support of Wisconsin Academy

Whether or not to continue a special subsidy to Wisconsin Academy was the main agenda item at the special constituency Nov. 7 at WA. By an overwhelming majority, delegates voted to reaffirm their strong support of the school.

The need for a special subsidy stems from projected low enrollment over the next few years. Currently enrollment stands at 105, down from last year's 114.

"This nation is an aging nation," Conference President **Arnold Swanson** noted. "We are probably not going to reach a 200 enrollment [WA's goal] in the near future."

The academy expects to remain at around 100 students for some time. To break even, an estimated enrollment of 155 is needed.

Wisconsin Conference has provided WA with a special subsidy of roughly \$100,000 a year since 1990. Funds not raised in the Wisconsin Budget Offering must come from other areas, thus depleting conference resources.

Report on academy

WA principal Steve Brown reported on recent student outreach activities. Twice monthly the entire student body is involved in community service as part of Bible classes, with

of 155 church delegates and 52 delegates at large, the following points concerning Wisconsin Academy:

- That Wisconsin Conference continue to give special financial assistance to Wisconsin Academy for the 1994-95 school year.
- That delegates, local elders and stewardship secretaries who are not delegates be encouraged to be active in supporting and promoting the Wisconsin Budget Offering of 2% of income, along with promoting a total program of stewardship.
- That a special constituency meeting be called again on Nov. 6, 1994, to review this matter and to transact other business as may properly come before the delegates.
- That the Lake Union be requested to survey the academy situation and make recommendations.

Students may also participate in four mission trips this year; seniors have voted to make their class trip a

mission project.

Brown also described extensive recruitment efforts. Out of 270 potential students contacted, he noted, 104 students chose to attend public schools.

Delegates respond

Several delegates expressed their personal support of Wisconsin Academy. "We want very much to support [WA]," said a Janesville member.

"I think we have something here that we can say 'Praise the Lord' for!" Pastor Wendell Springer, Portage district, said. Delegates applauded.

Elder Fred Stephan, Lake Union education director and former WA principal, gave a historical perspective.

"Those were crucial days," he said of earlier times of financial stress at the school, "and we worked through them.

"These kids are looking for something good," Stephan continued. "They want to serve the Lord. Most of our schools are doing far more witnessing than most of our churches."

After a brief discussion period, delegates voted on several points concerning Wisconsin Academy (see inset.) Fox Lake delegate **Ed Sajdak** reminded the group of their priorities:

"When the Lord comes," Sajdak said, "He's not going to want to know the financials. He's going to be interested in the souls."

Evangelism is working, notes president



"Sow your seed in the morning, and at evening let not your hand be idle, for you do not know which will succeed, whether this or that . . . " Eccl. 11:6. These verses

were fulfilled once again, Elder Swanson noted, in the recent major evangelistic thrust held in the Milwaukee area.

"We tried many different things, and each community responded differently," the president said. Eight evangelists conducted eight crusades during the past summer and fall months. Members from the ten area churches strongly supported the meetings, and new members or new interests are now found in every church. Before the year ends, nearly 150 new members will have joined these churches.

Baptisms and professions of faith (250 in 1991, 206 in 1992) equal the average of recent years. Missing and apostatized members during this time, however, have been more than double the average in recent years (209 in 1991, 288 in 1992).

In spite of the drop in membership (5,878 in Dec. 1992 from 6,017 in Dec. 1990), Swanson noted, the conference does show a tithe gain (see Treasurer's report, below).

Conference Treasurer Ken Wright commended delegates for the 4.1% tithe gain through Sept., 1993. "This is the

any Lake Union conference," he noted.

Giving to Wisconsin Budget as a percentage of income is higher here than in the other Lake Union conferences, he said. Wisconsin members gave 57 cents to Wisconsin Budget for every \$100 of income last year, an average of \$36.42 per member.

Currently 85% of Wisconsin Budget goes to Wisconsin Academy. Because of the crucial need for additional support of WA, Wright challenged delegates to "give just a quarter a day" to Wisconsin Budget. This would increase average per member giving to \$91.00 per year. Better yet, he said, "Join me and my wife in giving 2% of income to Wisconsin Budget."

As of Sept. 30, 1993, the conference Operating Fund balance was considerably more than the budgeted figure for the same period. Also encouraging is the fact that the major conference expense—pastor/Bible worker salaries and allowances—is under budget as of Sept. 30.

Year-end financial reports for 1991 and 1992 showed operating gains; we anticipate an operating gain for 1993 as well, Wright said.

Nine Steps Taken to Reduce Operating Costs in Wisconsin Conference

- 1. Pastoral staff has been gradually reduced. (35 pastors 15 years ago compared to 20 full-time equivalents today).
- 2. A ministerial director and an associate who took calls out of Wisconsin were not replaced.
- 3. Two department directors pastor churches on a part-time basis.
- 4. An extremely heavy load has been placed on the Church Ministries Director, including Adult Ministries, Children's Ministries, Earliteen and Youth Ministries, Family Life Ministries, Community Services, Prison Ministries, Health/Temperance, and ASI.
- 5. No seminary interns are currently sponsored.
- 6. While a larger Executive Committee has added costs, the committee now meets only every other month.
- 7. The gift of a partial salary from an out-of-state member was accepted in order to place a pastor at the LaCrosse and Hylandale churches without incorporating these churches into a five- or sixchurch district.
- 8. Chippewa Valley Hospital provides a portion of the area pastor's salary, as he works as part-time pastor and part-time hospital chaplain.
- 9. Ministerial councils and teachers' meetings are held at the conference office rather than elsewhere.

Milwaukee Hispanic churches hold baptism

One didn't have to speak Spanish to understand the significance of the baptism held Oct. 30 in Milwaukee's indoor Pulaski Pool. Eighteen people were baptized following crusades held this summer and fall by the four Milwaukee area Hispanic churches.

A poolside concert opened the evening, with songs by Thony Escotto, also known as "Tio Daniel" on the Spanish Story Hour radio broadcast; young Kelly Lauren Razzouk; and Saily Guerra, daughter of Pastor and Mrs. Orlando Vazquez.

Performing the baptisms were Elder Luis E. Leonor, Lake Union vice president; Pastor Vazquez; Conference Trust Services Director Richard Habenicht; Evangelist Miguel
Aldonia, president of the Nicaragua
Mission; and pastors
Elias Correa and
Winston Simpson,
also from Nicaragua.
The three Nicaraguan guests led the
Milwaukee crusades.

More baptisms are expected as a result of these crusades, said Pastor Vazquez.

When asked why he had chosen to be baptized, nine-year-old **Isaac**



Mercado, Racine Spanish, stated simply: "Because I know Jesus."

Members leave for two mission trips

About 20 Wisconsin members have volunteered for two mission trips to the Dominican Republic. Both are part of Operation Amigo, the Lake Union's church- and school- building project in its sister union.

Lake Union ASI members (six from Wisconsin) left Nov. 18 for San Francisco de Macoris. With Fred Miller, Madison East, as construction superintendent, the group started work on a new school.

Youth Director **Dale Ziegele** takes a Lake Union youth group of 20 to the same building site Dec. 8-22. Thirteen volunteers are from Wisconsin; five are students at Wisconsin Academy. **Don Evans**, Clearwater Lake, will supervise the construction crew.

"This is one of the most positive, life-changing experiences a young person can have," said Elder Ziegele.

As of October, Wisconsin members had raised \$14,094.97 for

Operation Amigo--nearly enough to build three of the five churches planned in the North Dominican, Wisconsin's sister conference.

Recently grades 1-3 at **Petersen Elementary School** in Columbus raised \$457.27 for Operation Amigo by baking and selling cookies.

Youth Educational Scholarship Pilot Program

Last year, 33 Youth Educational Scholarships (Y.E.S.) were awarded to students who otherwise would not have been able to attend Wisconsin Academy. In order to receive a Y.E.S. scholarship, a student must meet the criteria below:

- 1. Maintain passing grades.
- 2. Cooperate fully with work/study program (students over 16 work in industry).
- 3. Uphold school standards and rules.

In addition, the recipient's parents must show a definite financial need and make regular monthly payments on their financial commitment.

It takes \$50-\$60,000 to cover one year's Y.E.S. funds. To do this, the 1993-94 pilot program asks families and individuals to consider donating \$100 or more per year to the annual Y.E.S. fund. Several members of the Y.E.S. Committee, K-12 Board, and Finance Committee have launched the fund with \$100 each.

This annual fund will be used for Y.E.S. scholarships only; it does **not** replace the need for sponsors. Individual sponsors will still be needed for some individual students.
