### Corkum becomes Wisconsin's new president

When Arne and Millie Swanson announced their retirement this fall, the search began for a new conference president. As of Nov. 15, the search is over. Donald Corkum, president of the Alberta Conference, and his wife Phyllis will move "south" in January. Elder Corkum will then begin serving as Wisconsin Conference president.

"You've chosen a very fine person," said Elder Swanson at the Triennial Session on Nov. 12.

Phyllis Corkum will work in the conference office. The Corkums have three children: Sheri Lynn, Rhonda Michelle, and Brian Scott. Elder Corkum's resumé highlights:

## Balance and growth: an interview with Don Corkum

What were some of the factors that influenced you to come to Wisconsin?

I had been aware (through the Swansons) of some of the ministries going on in Wisconsin. I had heard positive reports about the field and about the involvement of members in many churches here. I felt my interests in ministry matched Wisconsin's, and I felt I could make a contribution. I thought my pastoring experience in both small and large churches could be a help.

You've been a conference president for several years. What do you emphasize in your administration? My priorities are to expand the work, so that means growth. At the same time, I am concerned that we disciple the people brought into the church—that there's a balance between evangelism and discipleship. We'd like to see every member find their ministry for Christ in service. We'd also like to see more youth involved in service.

How will your position here differ from working in Canada?
Basic ministry is not different, but there are organizational differences.
Working in the Lake Union will be different because in Canada we have only one union, which covers

about 5,000 miles. Here we have union involvement in many things.

What are some of your first impressions of Wisconsin?
It's very beautiful! We like the balance between rural and urban living. Our first Sabbath here [in Sturgeon Bay], we thought the fellowship was beautiful.

What else would you like us to know about you?

That together we can take some significant steps toward completing our mission here in Wisconsin. I enjoy working toward that goal from a team point of view.

### **30th Triennial Session meets**

A pleasantly lighthearted spirit prevailed at Wisconsin's 30th Triennial Session, which met Nov. 12 at Wisconsin Academy.

"I can tell you folks like these meetings," joked President Arne Swanson in his opening remarks. "I've been here six and a half years, and this is my eighth constituency meeting!".

Though the mood was light, several serious issues were on the agenda: the election of a new president; the reelection of the secretary-treasurer and departmental and service directors; and the possible sale of Rhodes Bake-N-Serve, a major employer of WA students, to Rhodes International.

Arne and Millie Swanson received a standing ovation for their 46 years of denominational service.

"We just want to look at you one more time," Lake Union President Don Schneider said with affection. The Swansons, who have served in Wisconsin since 1989, are retiring to their home in Maine the end of this year.

#### **Ballots** counted

Delegates elected Don Corkum, president of the Alberta Conference, to replace Swanson.

"I have worked with Elder Corkum," noted one delegate. "You will not find a more Christian man."

Delegates then reelected Ken Wright as secretary-treasurer. Departmental and service directors were reelected as follows:

#### Sale of Bake-N-Serv

Constituents also voted to sell the Rhodes Bake-N-Serv plant in Columbus to Rhodes International for \$600,000. The alternative was to build a new freezer in order to alleviate costly monthly rental of storage space.

Ken Farnsworth, president of Rhodes International, assured delegates that the sale of the bakery would not affect employment of Wisconsin Academy students.

"That's why we're here. . . We need *more* students," he said. Bake-N-Serv relies on student labor largely because it is cheaper, and because the school year coincides with the bakery's heaviest production schedule.

A surprise announcement came when Farnsworth made a pledge of \$210,000 from Rhodes International over a five-year-period to support Wisconsin Academy. These funds will go to the Quasi-Endowment Fund, with the interest being used for the operation of WA.

The day closed with strong support for our academy and our conference. After calling special

### Pastor Cal Johnson dies

Pastor Calvin Johnson died from complications of a quadruple bypass on Thanksgiving Day in Appleton. He had retired in October.

"He was a pastor to many of us pastors," said Elder Gaylan Herr (Columbus). Since moving back to Wisconsin from Michigan in 1988, Cal had served as a part-time assistant to the ministerial director. He was also an interim pastor and regular speaker in many churches around the conference.

Funeral services were held Nov. 27 in the Fox Valley Church.

Cal was born Oct. 2, 1923, in Appleton to James and Lulu (Ferguson) Johnson. He is survived by his wife, Mazie; two sons, Ross (Sue) and Kim (Nancy) Johnson; two brothers, Sheridan (Agnes) and Gwyn (Patricia) Johnson; four grandchildren; one step-grandchild; nieces and nephews.

During World War II, Cal served in Europe and the South Pacific. He received a purple heart, the Distinguished Flying Cross, and numerous other medals.

Cal worked in private construction and sales for 30 years before entering the ministry. He and his brother Sheridan built several schools and churches in Wisconsin.

In addition to pastoring in Wisconsin, Cal served churches in New Mexico, Washington, and Michigan.

### WA wins third yearbook award

For the third year in a row, Wisconsin Academy's yearbook has earned the ALL KEMPA AWARD from the Kettle Moraine Press Association, reports WA secretary Sue Rappette. WA's newspaper, the Wisconian, moved up to a second place rating in the competition.

Judges commended the publications for excellent photography and layout. "It's great to see a religious school not hide their religion," the judges wrote.

Many schools, both public and private, throughout Wisconsin and Illinois entered the competition sponsored by the Continuing Education of the University of Wisconsin. Yearbook editor was Kristin Smith; Nick Sigler was editor of the Wisconian.

### Treasurer's report: how much does a constituency meeting cost?

What's the average cost of a constituency meeting? About \$2,500 for each of the Special Constituency Meetings held in 1993 and 1994, estimates Wisconsin Treasurer Ken Wright. The Triennial Session cost roughly \$7,500. This is only an estimate, notes Wright, as all bills are not yet received.

Our Wisconsin tithe is up 4.93 percent over October of last year, Wright reports. "This represents very good news, since it includes one less Sabbath than last year," says Wright.
